"Easterseals continues to be a lifesaver for our family," says Lori, whose sister experienced a traumatic brain injury and has been attending Easterseals Adult Day Services for 10 years. "Thanks to guidance from the Veteran Staffing Network at Easterseals, I was able to land a project management role at a Fortune 500 company that exceeded my expectations," says Talha, who needed help conveying the value of his Navy service to a corporate position.



How Do Your Funds Make a Difference?

- \$5,000 covers a full day of care for 50 people in an Easterseals Medical Adult Day Center
- \$10,000 can help as many as 12 veterans and their family members with therapy sessions and treatment through the Steven A. Cohen Military Family Clinic at Easterseals
- \$15,000 provides 60 wounded warriors and their spouses with a day of respite while their children enjoy a fun-filled adventure at Easterseals
- \$25,000 enables a child with disabilities or the child of a wounded warrior to prepare for a successful life at Easterseals Child Development Center for an entire year
- \$50,000 provides 2,000 hours of one-on-one employment counseling for veterans, wounded warriors, and military family members
